

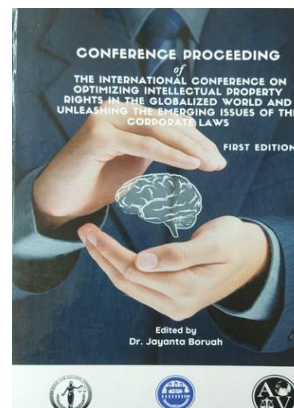
ACTIVITIES UNDERTAKEN

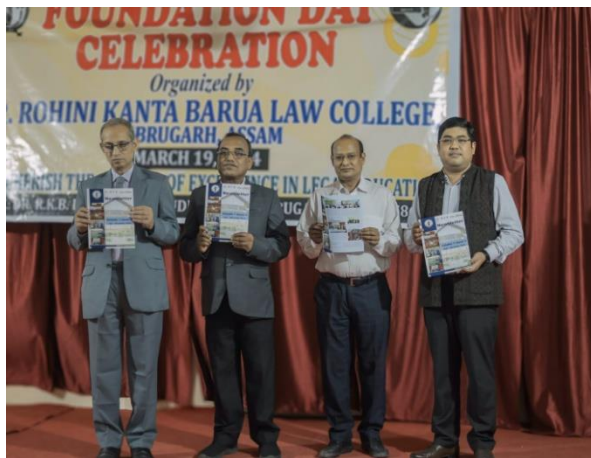
2. Publication of Conference Proceeding

3. Publication of Dr R. K. B. Law College Newsletter, Volume I, Issue II



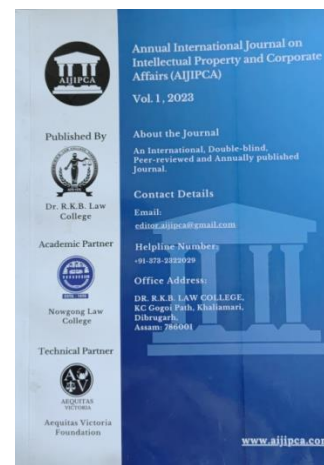
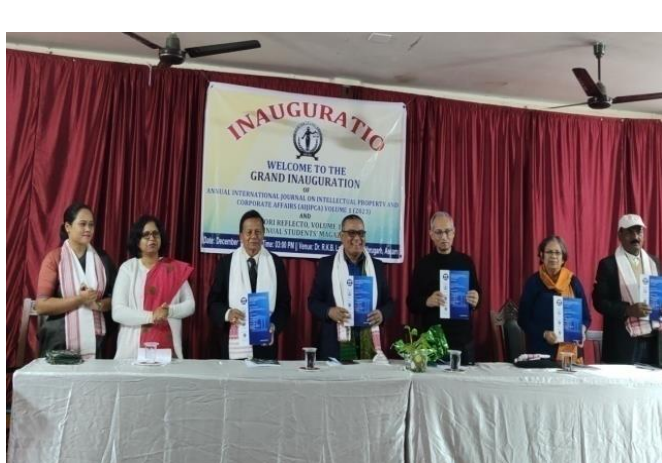

5. Publication of Journal



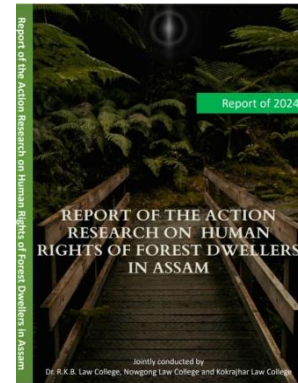

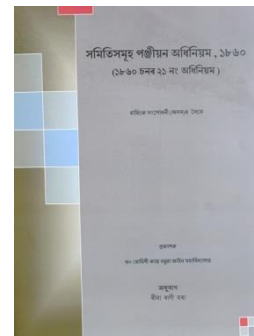
7. Publication of Report on Action Research

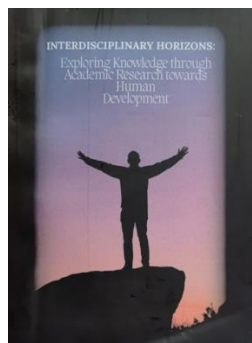
8. Publication of Assamese Translated version of Societies Registration Act, 1860.
